The fulfilment of Resolutions passed in the Meeting held on 18<sup>th</sup> February, 2022 were read and noted.

Further, the Principal has given the information to the Governing Body about the Department for industry Internships and other academic activities on Subject No 4 of the meeting dated 18<sup>th</sup> February 2022. The said department staff has identified 900 industries where our students could participate and take their training.

The Chairman has advised as follows:

- i) The work should be outcome based and justified.
- ii) The evaluation data of pass out students after completion of four years' degree course is to be prepared.
- iii) How many students are going for 6 months or 1 year courses for training in the industries after passing out from College? Who are the trainers are being used by Industries?
- iv) Training and Placement Officer will visit the companies and get the data from industries as how much is the recruitment of students from engineering colleges in their board, salary package for them and training courses arranged at their industry and collect information of space required for the training.
- v) Product of the company and respective department of company will be coordinated by us and find out the data in respect of respective department from HRA activity of Company and detailed information from them and problems faced by them while doing all the recruitment.
- vi) We can decide which could be an elective subject for student from 2<sup>nd</sup> year and make it an instrument in our syllabus to groom the students in a better way and make a Human Resource product for Industries as Human Resource of future development of nation.
- vii) When we come to conclusion and ready for decision afterwards we call the company for sign an MOU for training in our college/institute.
- viii) Industry offers training in the batch of 8 students in a cycle and how much cost which they have to spent on paying stipend for trainee engineers and the same cost can be reimbursed by Industry if we offer the space and required infrastructure in our Campus. We can implement the above courses from 2<sup>nd</sup>, 3<sup>rd</sup> and 4<sup>th</sup> Year and also waive off fees.

The Principal has also given the information to Committee about the Performance Based Appraisal System (PBAS) Report and Annual Confidential Report (ACR) of Teaching and Non-teaching Staff for sanction of annual increments on Subject No 19 of the meeting dated 18<sup>th</sup> February 2022. In this regards the College has submitted the proposal to Society Office for obtaining consultation from Society's Legal Adviser.
