Introduction

The major driving force for construction of dams throughout the world is the need for reliable water supply, flood control, navigation, hydroelectric power generation and recreation. Water demand and consumption worldwide is expected to grow exponentially in the years to come. Hence, there is a need for technological interventions for harnessing, conservation and proper management of water resources. Spillways are provided as integral part of a dam or as an auxiliary structure constructed separate from the main dam to release surplus flood waters which are in excess of the storage space in the reservoir as provided in the operation plan and must be passed downstream. The primary function of spillways is to release surplus water in conjunction with other discharging devices from the reservoir, in order to prevent rise of water level above a specified level in the reservoir to avoid unwanted submergence upstream or consequent overtopping and possible failure of the dam. Thus, spillways work as safety valves for a dam and the adjoining countryside.

The selection and design of a particular type of spillway is based on the specific purpose of the project, hydrology, release requirements, topography, geology, dam safety and project economics. Provision of a hydraulically efficient and structurally strong spillway is very important for the safety of the dam, and life and property along the river down below. The Bureau of Indian Standards has published a code of practice (IS: 10137 1982) highlighting guidelines for the selection of spillways and energy dissipators. The Waterways Experiment Station (1973) and US Bureau of Reclamation (1977) have done extensive experimental work on hydraulic design of spillways. Hydraulic models are used extensively to visualize and understand the complexity of hydraulic phenomena. Various hydraulic design aspects such as discharging capacity, pressures and water surface profiles and energy dissipation arrangement are considered, to evolve hydraulically efficient design of spillways. The width of the spillway plays a major role in the economic analysis and safety of the dam. Normally, a narrow spillway with higher discharge intensities would be less expensive than a wider spillway with moderate discharge intensities. This concept has resulted in large depths of over-flow over the crest of the spillway.

Aims and objectives

The aim of this study is to obtain the maximum energy dissipation by investigating the design of high head ogee spillway.

- Experimental work for various types of energy dissipaters for different bed angles.
- To find the optimum hydraulic jump length and sequent depth for head ogee spillway by studying various energy dissipaters and /or combinations of energy dissipaters.
- Assessment of energy dissipation by doing mathematical model study and experimentally verification of the performance of ogee spillway, Vaitarna Dam / Modaksagar Dam D05130, Mumbai, India.
- One of the main objectives is to design stilling basin to reduce the required length of the basin without sacrificing a well-developed hydraulic jump within the range of Froude numbers under consideration and optimum construction cost.
- More extensive investigations to determine the detailed information concerning the effects of boundary roughness on hydraulic jump by identifying flow conditions.
- To determine the most effective shape, size and block spacing with regards to effective velocity reduction and to analyze the relationship of effective shape, size and block spacing with the number of rows.
- Different shape corrugated bed channel to investigate the hydraulic jump characteristics.
- Sensitivity analysis to investigate the effect of the change of intensity and roughness length parameters on the hydraulic jump length.

Scope of the work

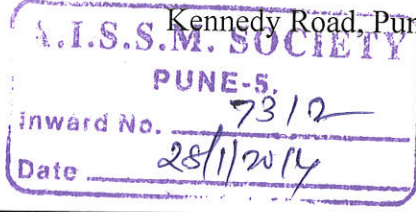
- The scope of this study is investigation in design of high head ogee spillway for maximum energy dissipation in developing cost effective and low deterioration design.
- Selection of best energy dissipater in finding low hydraulic jump length and optimum sequent depth.
- Suitable numerical analysis for designing the high head ogee spillway by considering the dissipation of energy.
- For structural design of various components of hydraulic jump type stilling basins and bucket type energy dissipaters below spillways.

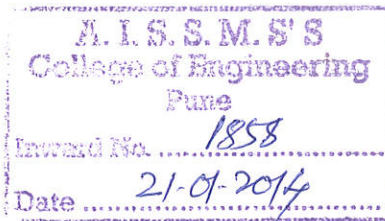

**Statues Governing Terms and Conditions of Service of
Teachers appointed in the University/Colleges and
Institutions conducted by the University/Affiliated
Colleges/Constituent Colleges/ Recognized Institutions of
the University of Poona**

(Under Section 42 and / or 73 of the Poona University Act, 1974)

(As modified up to the 01.04.1992)

(2) *Casual Leave:*

- (a) The teacher shall be entitled to 15 days casual leave in an academic year.
- (b) The application for casual leave shall ordinarily be sent before the date from which casual leave is required, an ex-post-facto sanction for the casual leave shall be ordinarily obtained by the teacher in exceptional circumstances where application of casual leave could not be sent before leave is enjoyed. Record of casual leave of the teacher shall be maintained.
- (c) The teacher shall not be entitled for more than seven days casual leave at a time together with prefix and suffix sundays/holidays. It could be extended to 10 days at a time only in exceptional circumstances. Holidays or Sundays falling between the period of casual leave shall not be counted as casual leave. The casual leave shall not be prefixed or suffixed to vacation or other type of leave except to special leave.

(3) *Earned Leave:*

- (a) The confirmed non-vacation teacher shall be entitled to earned leave at the rate of one-eleventh of the period spent on duty subject to his accumulating maximum of 180 days of leave.
- (b) The teacher other than the one included in (a) above shall be entitled to one twenty seventh of the period spent on duty and the period of earned leave as provided in the proviso to S. 423 subject to his accumulation of maximum of 80 days. For this purpose the period of working days only shall be considered.

(4) *Study Leave:*

- (a) The permanent whole-time teacher (other than Professor of the University) with more than five years continuous service may be granted study leave on full pay and allowances, together with leave due and admissible up to 28 months to pursue study in special line of research in India or outside directly related to his work in the University/College/Institution. If the teacher with the permission of the competent authority extends the study leave it shall be debited to his leave account or shall be treated as an extra-ordinary leave.
- (b) The teacher shall not be entitled for another study leave unless he has spent more than five years of duty since his return from study leave granted to him.
- (c) The teacher may alter substantively the course of study or the programme of research only with the prior permission of the Competent Authority.
- (d) In case the teacher completes his Study/Research Programmes prior to the expiry of the study leave sanctioned, he shall resume duty immediately unless he obtains prior approval of the Competent Authority. In case the teacher does not complete Study/Research Programme within the period of study leave sanctioned, the teacher shall with prior approval of the Competent Authority, avail of earned leave to his account to extra-ordinary leave.
- (e) The teacher who is granted study leave shall avail the same within six months of its sanction, otherwise it shall be deemed to have been cancelled, and the teacher shall have to apply for the same again.
- (f) The teacher availing the study leave shall undertake that he shall serve the University/College/Institution continuously for double the period of study leave subject to a minimum of three years from the date of his resuming duty after expiry of the study leave.
