PREAMBLE

Whereas, The AISSMS College of Engineering, Pune is affiliated to the Savitribai Phule Pune University, Pune and approved by AICTE. It conducts undergraduate courses in various engineering disciplines of Chemical, Civil, Computer, Electrical, Electronics, Mechanical, Mechanical Sandwich and Production Sandwich and post graduate engineering courses in Chemical, Civil (Structure), Computer, Electrical (Power Electronics and Drives), Electronics and Telecommunication (IoT and Sensors) and Mechanical Engineering (Design Engineering).

CREDAI-Maharashtra is the State Level Federation and is an apex body of the organised Real Estate Developers/Builders across the State of the Maharashtra (excluding Mumbai). 66 City Associations are members of the Federation with over 3500 individual members.

OBJECTIVES OF MOU

- 1. To promote social awareness about water and waste water management.
- 2. To reach out and provide learning opportunity in the area of water and waste water management with SCADA technology
- 3. To promote any other appropriate mode of interaction agreed upon by both parties.

Now, therefore this agreement is signed between the parties;

CREDAI-Maharashtra

Whereas, the following is agreed upon by both the parties

(A) SCOPE AND TERMS OF INTERACTION

The AISSMSCOE and CREDAI-Maharashtra shall encourage initiatives in the field of water and waste water management and related technologies through training and other platforms.

- 1. AISSMSCOE shall conduct certification courses in association with CREDAI-Maharashtra
- 2. AISSMSCOE shall be responsible for running the course batches successfully and for providing placement support to the students after successful completion the course.
- 3. AISSMSCOE and CREDAI-Maharashtra shall be responsible for the course promotion.
- 4. AISSMSCOE and CREDAI-Maharashtra shall arrange for counselling sessions for the interested students in the certification course.
- 5. AISSMSCOE shall conduct certification courses like Water purification treatment plant, Sewage treatment plant, Domestic and Commercial RO, Water and Wastewater Management Course. Minimum five students required for commencement of first three courses and fifteen students for last course.

(B) INTELLECTUAL PROPERTY RIGHTS

Rights regarding publications, patents, royalty, ownership of software/design/product etc. and course contents developed under the scope of this MoU, shall be with AISSMSCOE.

(C) CONFIDENTIALITY

The AISSMSCOE and CREDAI-Maharashtraagree to hold in confidence all information/data which is obtained from either side or created during the performance of the MoU and will not disclose the same to any third party without written consent of the other side.

(D) COORDINATORS

Both sides will designate one or two persons who will be responsible for overall coordination and implementation of this agreement.

(E) DURATION OF MOU

This MoU will come in force from the date of signing of the MoU by the representatives of both the parties and shall remain in effect till it is discontinued by mutual consent.

Once terminated, neither AISSMSCOE nor CREDAI-Maharashtrawill be responsible for any losses, financial or otherwise, which the other party may suffer.

This MoU is signed on this day of Monday of 04/09/23, by both the parties, subject to approval of the respective academic/administrative bodies.

This MoU is valid for 3 years.
