(D) CONFIDENTIALITY

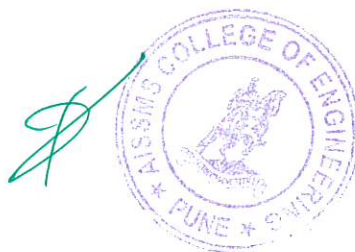
