वरिल दिलेल्या कार्यालयीन आदेशाप्रमाणे कमिटीने त्यांचे कामकाज दिनांक ०६.०३.२०१९ रोजी सुरू केले आणि दिनांक १९.०३.२०१९ रोजी पूर्ण केले आणि कमिटीचा अहवाल दिनांक १९.०३.२०१९ रोजी कार्यालयास सादर केला आहे .

सदर कमिटीचा अहवाल पाहता, विद्यार्थीनी कु. किरण राजेश देवरे यांनी शैक्षणिक वर्ष २०१५-२०१६ मध्ये केंद्रिय प्रवेश प्रक्रियेमधून एससी या मागास प्रवर्गातून प्रवेश घेतला होता . प्रथम वर्षामध्ये १ विषय राहिलेला होता . नंतर शैक्षणिक वर्ष २०१६-२०१७ मध्ये द्वितीय वर्षास प्रवेश घेतला होता . द्वितीय वर्षात सुध्दा काही विषय राहिले . दरम्यान कु. देवरे यांनी रिव्हल्युशन आणि व्हेरिफिकेशनसाठी विद्यापीठात अर्ज केलेला होता . यामध्ये प्रथम वर्षाचा राहिलेला एक विषय सुटेल असे वाटल्याने कु. देवरे यांनी रुपये १०,०००/- भरून शैक्षणिक वर्ष २०१८-२०१९ मध्ये तृतीय वर्षात प्रोव्हिजनल ॲडमिशन घेतले होते . विद्यापीठ नियमानुसार, प्रथम वर्षाचे सर्व विषय पास असल्यासच तृतीय वर्षाचा प्रवेश निश्चित होतो . अन्यथा प्रोव्हिजनल घेतलेली ॲडमिशन देखिल रद्द होते . तृतीय वर्षाच्या प्रथम सत्राचा परिक्षा अर्ज भरणे, विद्यापीठाचे हॉल टिकट मिळणे, ओरल-प्रॅक्टिकल देणे इ . सर्व बाबी पूर्ण झाल्याने, विद्यापीठाने प्रथम वर्ष क्लिअर नसल्याकारणाने तृतीय वर्षाच्या प्रथम सत्राचा निकाल राखून ठेवलेला होता . यामध्ये रिव्हल्युशन आणि व्हेरिफिकेशनसाठी केलेल्या अर्जाचा निकाल नो-चेंज असा लागला . पुढे कु. देवरे यांनी नोव्हेंबर २०१८ मध्ये राहिलेल्या विषयाची परिक्षा दिली आणि त्याचा निकाल फेब्रुवारी २०१९ मध्ये लागला त्यात त्यांचा विषय सुटला / त्या पास झाल्या . यामुळे कु. देवरे यांनी कॉलेजला विनंती केली की, मी तृतीय वर्षात घेतलेला प्रोव्हिजनल प्रवेश पुढे Continue करा . विद्यापीठ नियमानुसार, नापास झालेल्या

विषयास पुन्हा बसून पास झाल्याने त्याच सेमिस्टरमध्ये म्हणजे फेब्रुवारी २०१९ मध्ये तृतीय वर्षाचा प्रवेश Continue करता येत नाही. त्यासाठी पुढील जुलै महिन्यात प्रवेश घ्यावा लागतो. सबब कॉलेजने कु. देवरे यांना प्रवेश नाकारल्याने नाराज झालेल्या कु. किरण राजेश देवरे यांनी महाविद्यालयाकडे तक्रार केली, असे वाटते. त्यात त्यांनी कॉलेज कर्मचा-यांवर गैरवर्तनाचे आरोप केलेले आहेत.


कु. देवरे हया शिष्यवृत्तीच्या लाभधारक असल्याकारणाने त्यांचे आणि त्यांच्या पालकांचे श्री सुरेश श्रीरंग टेकावडे यांच्याशी संपर्क होत होता. अहवालात कथन केल्यानुसार, सहानुभुतीचे माध्यमातून सहकार्य करण्याचे प्रयत्न यामध्ये कु. किरणचे पालक व श्री टेकावडे यांचेकडून कार्यालयीन जबाबदारीच्या मर्यादांचे उल्लंघन झाल्याचे कमिटीस आढळून आल्याचे अहवालात नमूद केलेले आहे. सदरची मर्यादा ओलांडली गेल्याने गैरप्रकार होण्याचा संशय संभावित असल्याचे कमिटीने म्हटले आहे.





संदर्भित विषयास अनुसरून कमिटीने दिनांक 27.02.2019 रोजी कार्यालयीन आदेश प्राप्त झाला. त्यानुसार कमिटीने 28.02.2019 रोजी मिटींग बोलावून दोन्ही बाजूंचे म्हणणे ऐकून घेण्याचे ठरविले.

त्या अनुसार कमिटीने किरण देवरे यांना 06 मार्च 2019 व श्री सुरेश टेकावडे तुषार जगताप सुभाष दिवटे यांना 07 मार्च 2019 ला बोलावण्यात आले. त्यानुसार कमिटीपुढे मांडण्यात आलेल्या बाबींचा गोषवारा खालील प्रमाणे आहे.

1. किरण देवरे ही आपल्या आईसोबत दिनांक 6 मार्च 2019 ला सकाळी कमिटीपुढे आपले म्हणणे मांडण्या करिता आल्या होत्या. विद्यार्थी किरण देवरे हिने आपल्या महाविद्यालयात शैक्षणिक वर्ष 2015-16 मध्ये डीटीईमार्फत एअरबी प्रवर्गानुन प्रथम वर्ष स्निव्हीलमध्ये प्रवेश घेतला असून सद्धर विद्यार्थीनीचा मे 2018 च्या विद्यापीठ निकालानुसार प्रथम वर्षाचा "एक" विषय व द्वितीय वर्षाचे सहा विषय सलहिलेले आहेत असे दिशुन येते.
2. सद्धर विद्यार्थीनीस तृतीय वर्षाकरिता प्रवेशास पात्र होण्यासाठी प्रथम वर्षाचा विषय सोडविणे अनिवार्य आहे. तथापी मे 2018च्या निकालामध्ये तिने 32 क्रेडिट पॉईंट अर्जित केल्यामुळे किरण देवरेने तृतीय वर्षात विद्यापीठ नियामनुसार रूपये 10,000/- भरून प्रोव्हीजनल प्रवेश घेतला. (जोडपत्र क्र १ व २)
- किरण देवरे हिने शैक्षणिक वर्ष 2018-19 च्या प्रथम सत्रामध्ये प्रोव्हीजनल प्रवेश घेतल्यामुळे, प्रथम सत्रामधील विद्यापीठाचा अभ्यासक्रम पुर्ण केला. त्या अंतर्गत परीक्षा फॉर्म भरणे, विद्यापीठाकडून अॅडमीट कार्ड येणे, ओरल प्रॅक्टीकल देणे, तसेच विद्यापीठाची सत्र अखेरची लेखीपरीक्षा देणे, इ बाबी पुर्ण केलेल्या आहेत. तथापि प्रथम वर्ष क्लिअर नसल्यामुळे विद्यापीठाने किरण हिचा निकाल सख्खीव ठेवलेला आहे.
3. दसम्यानच्या काळात प्रथम वर्षाच्या न सुटलेल्या विषयाकरिता, तिने पुर्नमुल्यांकनाकरिता अर्ज केला व त्याचा रिजल्ट नो चेंज कारणाने सद्धर विषयाची पुन्हा नोव्हेसंडर 2018 मध्ये

परीक्षा दिली. सदर परीक्षेचा निकाल फेब्रुवारी 2019 मध्ये लागला आणि या परीक्षे दरम्यान तिचा विषय सुटलेला आहे.

४. प्रथम वर्षाच्या न सुटलेल्या विषयाचा पुनर्मुल्यांकनाचा रिजल्ट प्रथम सत्रामध्ये नो चेंज आल्यामुळे किरण देवरे ही विद्यार्थिनी तृतीय वर्षाच्या प्रवेशाकरिता पात्र ठरत नाही. या संदर्भामध्ये किरण व तिच्या पालकाची भुमिका अशी होती जर विद्यापीठाकडून हॉल तिकीट आले आहे आणि जर संपूर्ण तृतीय वर्षाचे प्रथम सत्र पूर्ण केले आहे तर कॉलेज माझ्या मुलीचे अॅडमिशन का कन्फर्म करित नाहीये? आणि तिच्याकडून फॉर्म का भरून घेण्यात आला ? तसेच सदर परीक्षा फॉर्म हा भरून घेत असताना तिचा प्रथम वर्षाचा विषय राहिला असताना देखील फॉर्म का भरून घेतला?
- या ठिकाणी किरणच्या पालकांचा आरोप आहे की विद्यार्थी विभागाकडून योग्य समणवय झाले नसून इतक्या दिवस आम्हाला फॉर्म भरून घेवून तो ग्राह्य होत नसल्याचे कळवण्यात का आले नाही?
- सदर संदर्भात किरण व तिचे पालक व श्री भालेराव विद्यार्थीविभाग प्रमुख यांचेशी झालेल्या वेळोवेळी चर्चेनंतर किरणच्या पालकांचा आरोप आहे की विद्यार्थीविभाग अजूनही प्रवेश देऊ शकते परंतु आता ते करणार नाहीत आणि माझ्या मुलीचा फॉर्म कॉलेजने बदल केला.

वरील आरोपाविषयी श्री भालेराव व श्री भोंसले यांनी मुलीला व तिच्या पालकांना प्रवेश प्रक्रिया समजवून सांगितली होती. तसेच विद्यार्थ्यांचा निकाल उशीरा लागत असल्याने विद्यापीठ सर्व विद्यार्थ्यांना फॉर्म भरून देण्यास परवानगी देते तसेच हॉल तिकीट देखील देते असे स्पष्ट केले. या प्रक्रियेमध्ये कॉलेजची भुमिका विद्यापीठ नियमास अधीन राहून केली जात असल्याचे किरण व तिचे पालक यांना नमूद केले गेले. (जोडपत्र क्र ३)

वरील बाबीचा विचार करता किरणच्या प्रवेशाची जबाबदारी महाविद्यालयाची आहे आणि विद्यार्थी विभागाचे प्रमुख श्री भालेराव यांनी "आम्ही किरणची अॅडमिशन करू शकतो परंतु, करणार नाही असे म्हणल्याचा आरोप करून महाविद्यालय प्रवेश करत नाही अशी समजूत करून घेतलेली आहे.

या सर्व खुलासेपार बाबी आणि दोन्ही बाजूने आलेले स्पष्टीकरण व पुरावे या आधारे वरील आरोप अथवा समजूत हे सत्य परिस्थिती जाणून न घेतल्याने किरण व पालकांनी केलेले आहेत, असे दिसून येते.

५. किरण देवरे ही एकाही प्रवर्गातील विद्यार्थिनी असल्याने, तिचा महाविद्यालयातील शिष्यवृत्ती विभागाचे, काम पाहणारे कर्मचारी श्री सुरेश टेकावडे यांच्याशी संपर्क आला. यासंदर्भात किरण देवरे व तिच्या आईने कमिटीपुढे खालील मुद्दे सांगितलेले आहेत.

- किरण देवरे हिच्या पालकत्वाची जबाबदारी तिच्या आईकडे आहे.

- शासनाच्या शिष्यवृत्ती विभागाकडे अर्ज करित असताना अर्जदाराची संपूर्ण माहिती द्यावी लागते. ज्यामध्ये उत्पन्नाचा दाखला देणे आवश्यक असते. अर्जामधील त्रुटीची पुर्तता करणे हे आवश्यक असल्या कारणामुळे विद्यार्थी पालक व संबंधित विभागाचे कर्मचारी एकमेकांच्या संपर्कात राहतात. या कारणामुळे किरणचे पालक व श्री टेकावडे यांचा वैयक्तिक फोन वरून माहितीची देवाण घेवाण झाल्याचे दिसून येते. या मुळेच किरणचे पालक व श्री टेकावडे यांची ओळख झाली व एकमेकामध्ये माहितीची देवाणघेवाण सल्ला आणि मार्गदर्शन झाल्याचे दिसून येत आहे. (जोडपत्र क्र ४)
- हे सर्व होत असताना परस्परसंचे विचाराची देवाणघेवाण होत असताना किरण व तिचे पालक यांचे वैयक्तिक घरगुती माहिती थकढल ही संभाषण झालेले दिसत आहे. ज्यामध्ये रात्री उशीरापर्यंत फोनवर संपर्क झाल्याचे निर्देशीत झाले आहे.
- या संभाषणा दरम्यान किरणच्या आईला नोकरी नसून त्या नोकरीच्या शोधात आहेत किंवा स्वतः किरणच्या पालकांनी त्यांना नोकरी करण्याकरिता कोठे संधी आहे का याची विचारणा श्री टेकावडे कडे करणे तसेच स्वतःचा रिझ्युम त्यांच्याकडे देणे किंवा श्री टेकावडे यांनी किरणच्या आईस आपल्या सोसायटी मध्ये नोकरीकरिता प्रयत्न म्हणून भेटण्याचे सुचविणे इत्यादी बाबींचा समावेश झाल्याचे दिसून येते.
- किरणने कमिटीपुढे केलेल्या खुलाश्यानुसार जेव्हा ती तिच्या मैत्रिणी सोबत प्रथम वर्षाचा न सुटणाऱ्या विषयाच्या निकालाबाबत चर्चा करित असताना त्या वेळी श्री टेकावडे यांनी "तु काळजी करू नकोस आपण हा विषय सोडणु" असे सांगितले. त्या संदर्भात किरण व तिच्या पालकांशी संपर्क पाडविला. या ठिकाणी किरण व तिच्या पालकांनी दिलेल्या माहितीनुसार किरणच्या पालकांनी किरण ला अश्या कोणत्याही प्रकारे वैयक्तिकपणे करून आपणास विषय सोडवायचा नाही तु अभ्यास कर आणि विषय सोडव असे किरणला मी सांगितले असे कमिटीस स्पष्ट केले. या ठिकाणी वरीलप्रमाणे आपली भुमिका स्पष्ट आहे तर विषय सोडविणे या संदर्भात वैयक्तिकपणे पुढे जाण्यासाठी आपण पुढे कसे काय राजी झालात या कमिटीच्या शंकेस किरणच्या आईने खुलासा दिला की श्री टेकावडे यांनी माझे खुप चांगल्या पध्दतीने खेन पॉश केले पुढे जाऊन त्यांनी असे सांगितले की श्री टेकावडे यांची मुलगी आय ओ आय टी येथे शिकत असून तिचे ही विषय असेच सोडविलेले आहेत या पुर्णमुल्यांकनाच्या निकालाबाबत आपण जगताप व दिवटे यांची मदत घेऊ.

हे सर्व ऐकून मी ह्या प्रकारे पुढे जाण्यास तयार झाले व माझेकडे नोकरी नसताना देखील मी वेळोवेळी जानेवारी २०१८ पासून थोडी थोडी रक्कम असे



करित श्री टेकावडे यांना पैसे दिलेले आहेत. या संदर्भात कमिटीस कोणताही संशय पुरावा निर्दर्शनास आला नाही.

- तृतीय वर्षाच्या प्रवेशाकरिता पात्र होण्याकरिता मे 2018 च्या प्रथम वर्षाचा विषय पुर्ण मुल्यांकनामध्ये झुटणे अति आवश्यक होते याचे दडपण किरण व तिच्या आईवर होते.
- पुर्णमुल्यांकनाचा निकाल नो चेंज आल्याने श्री टेकावडे यांनी दिलेले आश्वासन पुर्ण झाले नाही. तसेच त्यांनी श्री टेकावडेना निकालात नोचेंज आल्याबद्दल विचारले असता, एका मुलीकरिता मी माझे विद्यापीठाशी असलेले विलेक्षण व्यवहार करू शकत नाही, असे स्पष्टीकरण दिले. या ठिकाणी यांच्या अपेक्षा भंग झाल्यामुळे असे अनेक विद्यार्थ्यांकडून पैसे घेऊन गैरप्रकार केले जातात असे नमुद केले.

त्याच अनुषंगाने किरणने दोन आणखी विद्यार्थीनींची नावे सांगितली त्यापैकी एक नाव चुकीचे होते तर दुसऱ्या विद्यार्थीनी श्री शाहनिशा केली असता असा गैरप्रकार आढळून आला नाही असे कमिटीच्या निर्दर्शनास आले. (जोडपत्र क्र ५)

- किरण हिने सदर विषयाची पुन्हा नोव्हेंबर 2018 मध्ये परीक्षा दिली. सदर परीक्षेचा निकाल फेब्रुवारी 2019 मध्ये लागला व तिचा विषय झुटला. विषय झुटल्यामुळे किरणने तिच्या आजोशामार्फत परस्पर एनईएफटी द्वारे रुपये 115000/- महाविद्यालयाच्या बँक खात्यावर जमा केले. असे किरणच्या पालकांचे म्हणणे आहे. (जोडपत्र क्र ६)
- तदनंतर किरण ने स्वतःची प्रोव्हीजनल अॅडमिशन कन्फर्म करण्याकरिता बँडूडंट सेक्शनला जाऊन एनईएफटी द्वारे बँकेत भरणे केलेली बँक डिपॉझिट बिलप दाखवून माझी अॅडमिशन कन्फर्म करावे असे सांगितले. या ठिकाणी बँडूडंट सेक्शन अॅडमिशन कन्फर्म करू शकते हे त्यांच्या हातात आहे. असे पालकांनी नमुद केले. परंतु विद्यार्थी विभागाने ते केले नाही असा त्यांचा आरोप आहे.
- किरणच्या आईने पुढे नमुद करताना असे ही सांगितले की त्या रहात असलेल्या प्रभागातील नगरसेवकांनी माझ्याशी संपर्क केला. आणि सदर प्रकरणात किरण हिचा प्रवेश आणि पुर्णमुल्यांकन या विषयास अनुसरून जी मी भूमिका घेतलेली आहे त्या संदर्भात आपण दुखावले गेले असल्यास त्या बद्दल माफी मागण्यास श्री टेकावडे श्री दिवटे श्री जगताप हे तिघेही तयार आहेत, असे सांगितले. मी मा. नगरसेवक यांना बँकेत एनईएफटी द्वारे भरणे केलेली बँक डिपॉझिट बिलप दाखविली.

निवेदन देत असताना किरण ने पुढे सांगितले की, माझे वडील पीएनआय आहेत, त्यांना झाला प्रकार सांगितले आहे. त्यावर आपण हे सर्व कमिशनर यांच्या कानावर टाकु असे वडील म्हणाले. जर यामध्ये माझ्या वडीलांनी लक्ष घातले तर प्रकरण कोणत्याही स्तरावर जाऊ शकते. व ते काय करतील यावर माझा ताबा नाही, असे तिने सुतोवाच केले. पुढे कॉलेजवर आरोप करताना श्री टेकावडे, श्री दिवटे, श्री जगताप यांच्यावर कार्यवाही व्हावी असे त्यांचे म्हणणे होते.

श्री टेकावडे दिनांक ७ मार्च २०१९ ला सकाळी कमिटीपुढे आपले म्हणणे मांडण्या करिता आले. त्यांच्या विश्लेषणातील मुद्दे खालीलप्रमाणे आहेत (जोडपत्र क्र ७)

श्री टेकावडे हे शिष्यवृत्ती विभागाचे काम पाहतात. किरण ही एसबी प्रवर्गातील स्टुडंट असल्याने 2015 पासून तिचा शिष्यवृत्ती विभागाकडे संपर्क झाला आहे. विद्यार्थ्यांना शिष्यवृत्तीचे अर्ज भरणेपासून, बदल अर्ज संबंधित विभागाकडे पाठविणे, त्रुटी दुरु करणे, फॉलोअप घेणे, या सर्व गोष्टीकरिता अनेक वेळा विद्यार्थी कामकाजच्या वेळोवेळी सुद्धा श्री टेकावडे यांच्याशी संपर्क साधत असतात. तसेच विद्यार्थ्यांना शिष्यवृत्ती विभागातून कामाची प्रगती वेळोवेळी झालेल्या त्रुटी व पुर्तता या करिता माझा मोबाइल नंबर विद्यार्थ्यांकडे दिलेला आहे तदनुसार मुले व पालक मला संपर्क करित असतात.

विद्यार्थी किरण देवरे व तिचे पालकांशी याच कारणामुळे संपर्क पाडला व दरम्यानच्या काळात पालकासोबतची ओळख पाडीस लागली. वेळोवेळी झालेल्या चर्चेमधून किरण हिचे विषय राहिलेले आहेत व त्यामुळे न सुटणारा M - II हा विषय व तिला होणारा मानसिक ताण या सर्व गोष्टीचे मी त्यांना धीर देण्याच्या उद्देशाने व आधार देण्याच्या हेतुने विषय सुटण्यासाठी प्रयत्न कर असा सल्ला दिलेला आहे.

आईचे व श्री टेकावडे याचे संपर्क पाडीस लागले कारणाने मुलीच्या आईने त्यांची वैयक्तिक माहिती जसे नोकरी नसणे इ. चा उल्लेख श्री टेकावडे याचेकडे केल्याचे दिसून येत आहे. तसेच मुलीचा फी भरण्याकरिता उत्पन्नाचा दाखला कोणाचा आवश्यक आहे याबबत मार्गदर्शन केलेले आहे.

श्री टेकावडे यांनी पुढे असे सांगितले की शिष्यवृत्ती घेणारे विद्यार्थी संख्या ही जवळपास 1200 ते 1500 च्या दरम्यान असते. शिष्यवृत्तीची प्रक्रिया ही ऑनलाइन व वेळेत करावयची असल्याने काहीवेळा कामाची पुर्तता करण्यासाठी आम्हाला उशीरा पर्यंत थांबावे लागते. या ठिकाणी वेळोवेळी रात्री उशीरापर्यंत कामाच्या पुर्ततेकरिता महाविद्यालयात थांबण्याचे मान्य केलेले आहे.

किरण देवरे हिने दिलेल्या लेखी तक्रारीमुळे श्री टेकावडे घाबरले व त्या भिती पोटी त्यांनी किरण बहात असलेल्या दिघीच्या नगरसेवकांशी संपर्क केला. या घटनेमधून त्यांचे व किरणच्या पालकांमधील संबंध वैयक्तिक पातळीपर्यंत पोहचल्याचे दिसून येते.



किरण देवरे हिचे प्रथम वर्षाचे विषय ओडविणे या करिता मी कोणताही प्रकारे पैसो घेतलेले नसुन या संदर्भात मला वेळोवेळी पैसे देण्यात आल्याचा किरणच्या आईचा दावा टेकावडे यांनी दावा पूर्णपणे अमान्य केला आहे.

श्री जगताप यांनी दिलेल्या खुलाऱ्यानुसार (जोडपत्र क्र ८)

किरण देवरे यांना पुर्नमुल्याकन प्रकरणी त्यांना लागणाऱी माहिती वेळोवेळी दिलेली आहे. मात्र कामकाजा दबक्यान किरणच्या आईने माझा डल्लेख एकेरी नावाने केला असुन माझ्या वर खोटे आरोप केलेले आहेत असे सांगितले आहे.

श्री दिवटे यांनी सांगितलेला तपशीलानुसार (जोडपत्र क्र ९)

श्री दिवटे यांचा किरणच्या आईबरोबर प्रोव्हीजनल अॅडमिशनबाबत कोणताही संपर्क झालेला नाही. तसेच रिहॅल व रिबिहॅलचे रिजल्ट या अनुषंगाने कोणतेही संभाषण व वाद झालेला नाही, तथापि प्रोव्हीजनल अॅडमिशन कन्फर्म न झाल्याने त्यांनी खोटेनाटे आरोप करित अरेबावीची भाषा वापरलेली आहे.

स्टुडंट सेक्शन इनचार्ज श्री भालेराव यांनी त्यांची आजु स्पष्ट करताना असे सांगितले की, किरणचा रिजल्ट नो चेंज असले कारणामुळे प्रोव्हीजनल अॅडमिशन कन्फर्म होत नाही. पुढे श्री भालेराव यांनी असे सांगितले की संभाषणा दबक्यान २१ फेब्रुवारी २०१९ रोजी मुलीच्या आईने श्री दिवटे यांनी फॉर्म घेत असताना "माझ्या मुलीशी गैरवर्तन केले", असा आरोप केला आहे. या ठिकाणी श्री भालेराव यांनी आपण असे कोणतेही खोटे आरोप करू नये, कारण फॉर्म हा दिवटेनी न घेता मी घेतलेला आहे. कारण ते त्या दिवशी बजेवर होते असे मुलीच्या आईस स्पष्ट सांगितले. परील प्रसंगानुन सत्य परिस्थितीची कल्पना न घेता आरोप करणे असे किरणच्या आईचे वर्तन दिसुन येते.

परील सर्व बाबींचा विचार केल्यानंतर कमिटीचे म्हणणे खालीलप्रमाणे





१ पहिल्या वर्षाचा विषय राहिला असतानादेखील तिच्या द्वितीय वर्षाच्या निकालानुसार किरणने तृतीय वर्षात तात्पुरता प्रवेश घेतला. (जोडपत्र क्र १०) त्यानुसार तृतीय वर्षातील प्रथम सत्रामधील सर्व शैक्षणिक पूर्तता करणेस विद्यापीठ नियमानुसार काही अडचण आली नाही. त्यानुसार तिने विद्यापीठाचा परीक्षा फॉर्म भरला तिचे हॉल तिकीट पण प्राप्त झाले तथापी सर्व शैक्षणिक सत्र पूर्ण करून देखील तिचा प्रथम वर्षाचा विषय न सुटल्याने तृतीय वर्षाचा निकाल विद्यापीठाने राखुन ठेवला आहे.

२ विद्यापीठ नियमानुसार विद्यार्थी किरण देवरे हिचा प्रथम वर्षाचा पुर्नमुल्याकमांचा निकाल मागील सत्रामध्ये नो चेंज असल्याने सद्य शैक्षणिक वर्ष २०१८-१९ मध्ये प्रवेशास पात्र ठरत नाही. असे असताना देखील पालकांनी परस्पर महाविद्यालयाच्या खात्यावर बँककम रुपये ११५०००/- भरलेले आहेत.

- ३ प्रथम वर्षाचा विषय झुटणे करिता किंवा पुर्नमुल्याकनांमधील विषय सोडवुन देणे इत्यादी खात्री किंवा तत्सम प्रकारची गैर मार्गाने केली जाणाऱी मदत या बाबत श्री टेकावडे यांनी कोणताही गैर प्रकारे मदत केल्याचे पुर्णपणे नाकारले आहे तसेच या बाबत पैसे घेऊन काम करतो असे आरोप केलेला दावा पुर्णपणे अमान्य केला आहे. व या संदर्भात कोणताही पुरावा कमिटीस प्राप्त झाला नाही.
- ४ श्री दिवटे व श्री जगताप यांचा विद्यार्थी विभागाचा कामाचा भाग म्हणुन विद्यापिठातील परीक्षा विभागाशी संबंध येत असतो या संदर्भात श्री टेकावडे यांच्या कडुन जगताप व दिवटे यांचे नांव विद्यार्थी किरण हिचे विषय सोडविण्याकरिता मदत घेऊ असे किरणच्या आईने सांगितले या ठिकाणी असे दिसते की श्री दिवटे व श्री जगताप हे दोघे ही संबंधित प्रकरणामध्ये श्री टेकावडे यांच्या सोबत सामिल आहेत असा समज किरणच्या आईने करून दोघांच्या नावाचा ही समावेश केला परंतु ह्या दोघांनी याप्रकरणामध्ये आमचा समावेश नसुन केलेले आरोप आम्हास अमान्य आहे असे सांगितले.
- ५ केवळ शिष्यवृत्तीच्या निमित्ताने झालेला संपर्क तदनुसार सहानुभुतीचे माध्यमातुन सहकार्य करण्याचे प्रयत्न यामध्ये किरणचे पालक व श्री टेकावडे यांनी कार्यालयीन जबाबदारीच्या मर्यादांचे उल्लंघन झाल्याचे कमिटीस आढळुन आलेले आहे. सदरची मर्यादा ओलांडली गेल्याने गैरप्रकार होण्याचा संशय संभावित आहे.
- ६ सदर प्रकरणात अर्जदाराने केलेल्या गंभीर आरोपामुळे घाबरून जावुन संबंधित महाविद्यालयातील अधिकारी यांच्या व्यतिरिक्त जाहेरील व्यक्तीचा समावेश करून सदर प्रकरणात श्री टेकावडे श्री जगताप व श्री दिवटे हे तिघे मागे घेण्याच्या भूमिकेतुन घेतलेली मदत ही अस्वीकार्य आहे.
- ७ सदर प्रकरणामध्ये वेळोवेळी झालेल्या संभाषणानुसार मुलीच्या आईकडुन विद्यार्थी विभागातील कर्मचाऱ्यांना एकेरी नावाने संशोधणे तसेच अरेरावी ची भाषा वापरून दबाव आणणे कृत्य घडले आहे. त्यामुळे कर्मचारी दबावाखाली आलेले दिसुन येत आहेत.

- १० शिष्यवृत्ती विभागातील कामाच्या स्वरूपाची संवेदनशीलता पाहता त्या ठिकाणी नैतिक दृष्ट्या जबाबदार, वैचारिक, परिपक्व व्यक्तीची नियुक्ती असणे आवश्यक वाटते.
